## 3. Perquisites

#### 5. Minimum Remuneration:

Where in any financial year during the period of his office as the Managing Director, the Company has no profits or its profits are inadequate, the above remuneration including perquisites shall be paid to Dr.D.Mohan Rao as minimum remuneration.

#### 6. Other Terms

Dr.D.Mohan Rao shall subject to the superintendence, control and direction of the Board of Directors, manage and conduct the business and affairs of the Company. He shall not be paid any sitting fee for attending meetings of the Board.
